DESCRIPTIVE OVERVIEW OF THE 2011 RELEASE COHORT

Executive Summary

At the end of each year, a descriptive overview is prepared of those offenders released during the year. This allows us to monitor any changes in the population and track trends from year to year. Data is used for population management and program development.

Sentenced offenders released to the street will be tracked for three years post release as part of our ongoing recidivism study. Recidivism rates are reported at one and three-year intervals.

There were 4747 releases from the HCSD in 2011 (599 females, 4148 males). This represents a decrease of 363 (7%) from 2010.

A total of 1826 sentenced offenders were released (238 females, 1588 males), a decrease of 232 (11%) from 2010. 1718 sentenced offenders (222 females, 1496 males) were *released to the street* via parole or expiration of sentence, a reduction of 10% from the previous year. 172 sentenced offenders were released to other authorities.

A detailed analysis of sentenced offenders released to the street can be found in **Section I**.

There were 2921 pretrial releases (361 females, 2560 males), a decrease of 4.3% from 2010. 2471 pretrial detainees were *released to the street* via bail, release at court or sentence to time served (337 females, 2134 males). 192 detainees were released to other authorities and 39 probates purged or paid their debt and were released.

A detailed analysis of the pretrial release cohort can be found in **Section II**.

227 individuals (7 females, 220 males) received a sentence to Mass DOC and were transported to MCI Framingham or MCI Cedar Junction. 7 offenders (4 females, 3 males) were transferred to a DOC facility for a reason other than a new sentence or VOP. These reasons included commitment to Bridgewater State Hospital, DOC Reentry Program failure or court appearance on existing case.

SECTION I SENTENCED RELEASES TO THE STREET

Summary

Number and Gender

The breakdown by gender was 1496 males and 222 females, representing 87% and 13% of the total population, respectively.

The 1496 sentenced males released to the street in 2011 represented a 9% decrease from 2010.

The 222 sentenced females released to the street in 2011 represented a 14% decrease from 2010.

The release cohort represented 1634 unique individuals (1433 males, 212 females). 59 males and 10 females were released twice during 2011, and 2 males were released three times.

Race and Ethnicity

The racial and ethnic breakdown is different for males and females. 70% of women identify themselves as Caucasian, 18% as Hispanic and 12% as African American.

In contrast, 38% of men identify themselves as Caucasian, 42% as Hispanic and 19% as African American.

Age

The mean age of the female population (36 years, 37 days) is nearly two years higher than the male population (34 years, 51 days).

16% of females are under age 25 compared to 23% of males. 34% of females are over age 40 compared to 29% of males.

Most common age for women is 26, for men 24.

LSI Screening Results

Mean LSI score for women was 4.42, for men 5.01. Most frequently occurring score for women was 5, for men 6.

27% of women and 44% of men scored as High-Risk (6-8). Only 8% scored as Low-Risk (0-2).

The number of females unemployed increased 15%. Those reporting poor family relationships increased 14%.

Among men, the pattern of criminogenic factors was consistent with the previous year.

35% of females and 50% of males lacked a high school diploma or GED at intake.

Residence

84% of males and 63% of females provided a Hampden County address at intake. Hampshire County had the largest number of out-of-county offenders.

55% of Hampden County offenders gave a residential address in Springfield, 16% Holyoke and 10% Chicopee.

Neighborhoods accounting for the largest number of offenders from Springfield were Mason Square (01109) and Forest Park (01108) with 26% and 23% respectively, and Central (01105) 17%.

24 offenders (3 females, 21 males) failed to provide an address at intake.

Governing Offense

14% of women and 30% of men were serving sentences for violent offense(s). 118 offenders were serving a sentence for a technical violation of parole and 6 for violating lifetime parole. 70% of technical violators were nonviolent offenders.

The breakdown of Lifetime Parole violation sentences in 2011 was 1 for a first offense (30 days), 3 for a second offense (180 days) and 2 for a third or subsequent offense (365 days). All violations of Lifetime Parole result in a county sentence in the offender's county of residence, regardless of the facility from which they were paroled.

Sentence

Mean sentence for women was 212 days (7 months, 2 days), for men 271 days (9 months, 1 day). Most common sentence for both genders was 180 days.

Females served a mean of 142 days (67% of sentence). Men served 191 days (71% of sentence). Percentage of sentence served increased due to the significant drop in paroles.

52 women (24%) were sentenced to 60 days or less. 46 (21%) were sentenced to a year or more. For men, 323 (22%) had sentences of 60 days or less, and 469 (31%) were sentenced to a year or more.

Mandatory days served totaled 46,730, a decrease of over 53,000 days from 2010. This significant drop can be attributed to the overall decrease in our count, fewer school zone and lifetime parole violations and a ruling that the 60-day sentence for a non-OUI suspension of license is no longer mandatory. Releases from a county sentence for a school zone violation decreased from 65 in 2010 to only 25 in 2011.

Classification

51% of women and 60% of men were released from lower security. 320 men attained minimum status in the Community Reentry Unit and 25 men achieved prerelease status in the CRU.

60% of those released from lower security had scored 5 or higher on the LSI. This confirms our policy of promoting step down even for those who are assessed at intake as high risk to recidivate if they comply with their service plan.

Employment, family relationships and mental stability were the major factors differentiating lower security and medium security releases. Offenders motivated to address these issues were more likely to earn their way to lower security prior to release.

Release Type

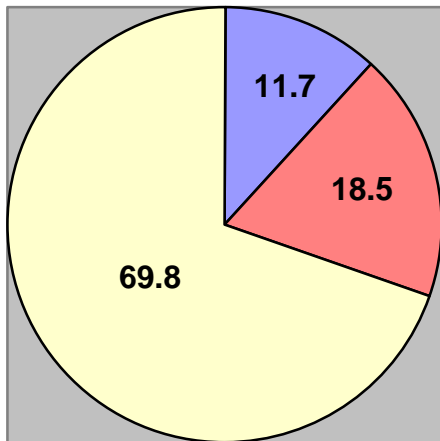
Paroles accounted for 12.0% of releases in 2011, a nearly 50% decrease from 2010.

Parolees served approximately 51% of their original sentence compared to more than 75% for those who completed their sentence.

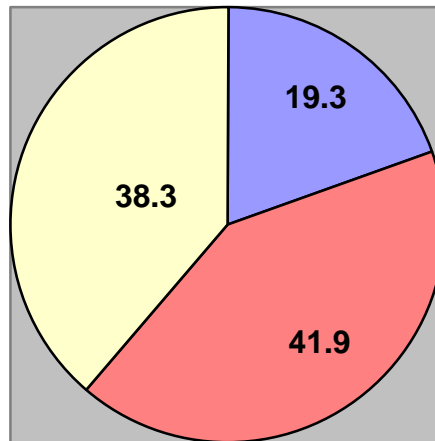

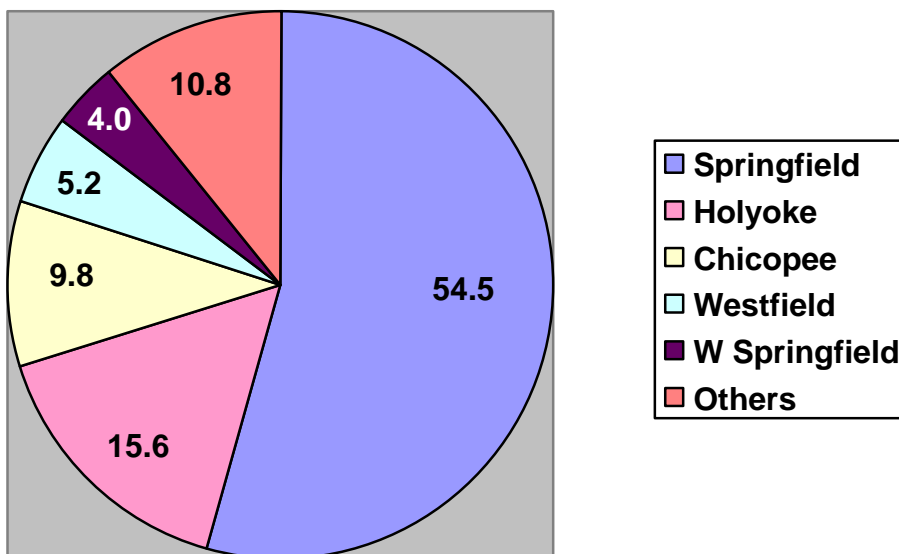

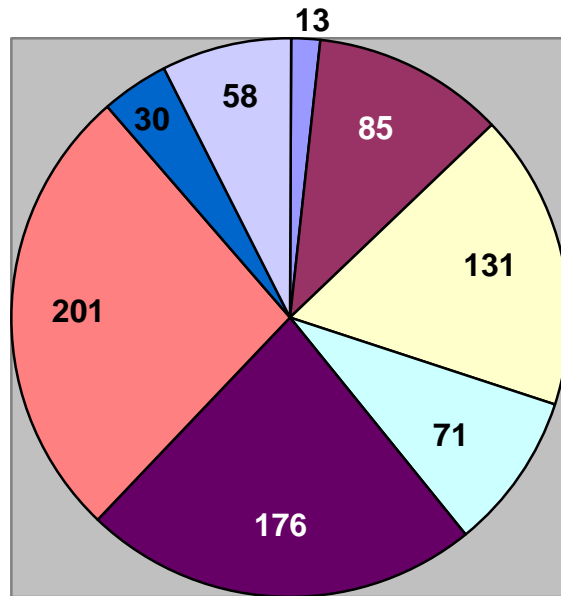

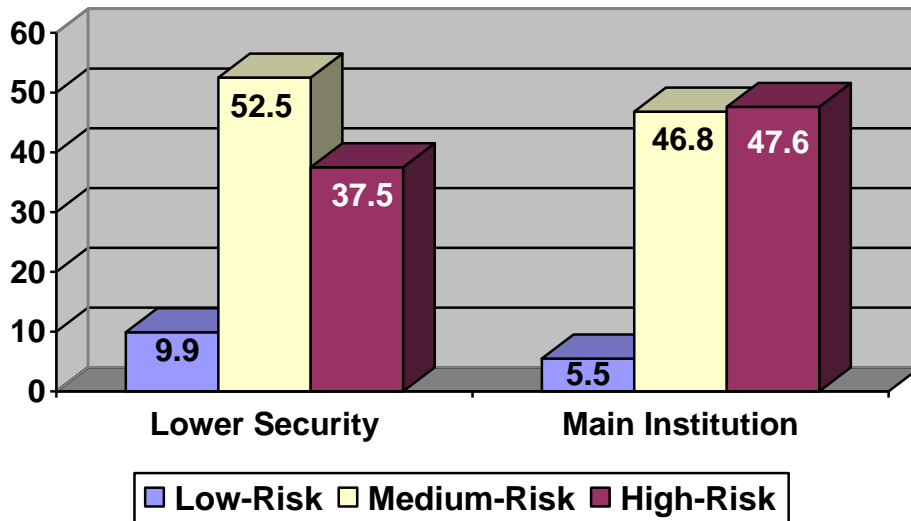

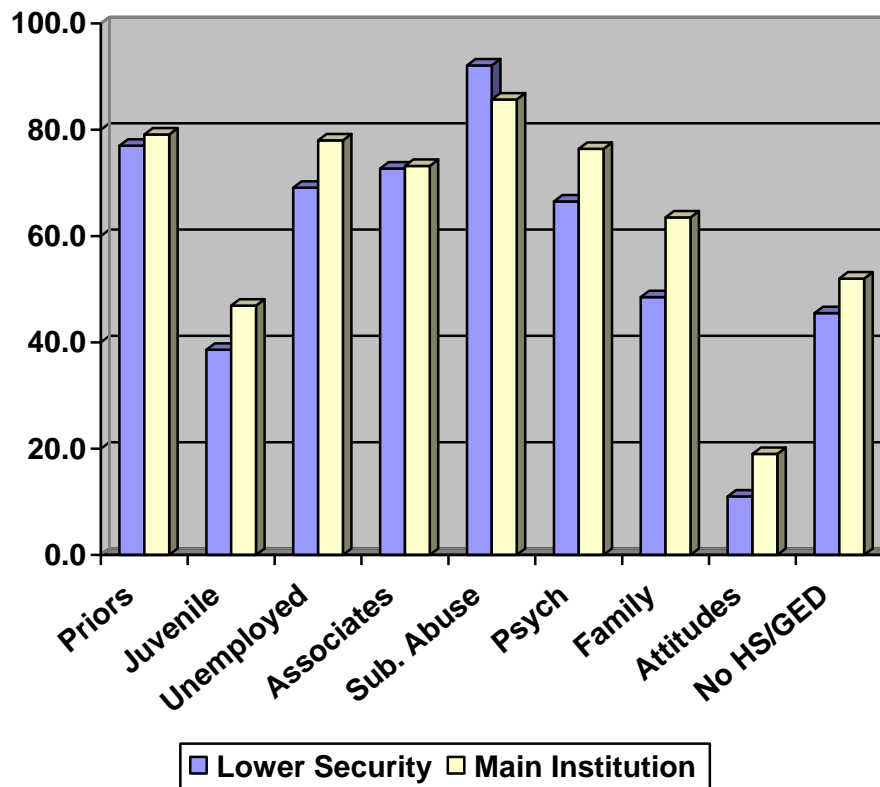
LSI Risk by Security Level

SECTION II PRETRIAL RELEASES TO THE STREET

Summary

Number and Gender

There were 2471 pretrial releases to the street in 2011, 337 females and 2134 males.

The group represented 2237 unique individuals (294 females, 1943 males). 152 males and 28 females were released twice during the year, 15 males and 3 females were released three times and 3 males and 3 females were released four times.

765 (31%) were bailed, 1466 (59.3%) were released at court and 240 (9.7%) were found guilty and sentenced to time served.

Race and Ethnicity

The racial and ethnic breakdown for the pretrial population reveals a higher percentage of minorities than the sentenced population, particularly among males. 66% of pretrial males are minorities compared to 61% of sentenced males. For women, the figures are 34% and 30% respectively.

15% of females and 23% of males identify themselves as African American, 19% of females and 43% of males as Hispanic, and 65% of females and 34% of males as Caucasian.

Age

As with the sentenced cohort, the female population tends to be older than the male population.

24% of females are under age 25 compared to 33% of males.

Most common age for women is 27, for men 21.

Overall, the pretrial population is younger than the sentenced population.

Residence

37% of females and 53% of males gave a Springfield address at booking. 7% of females and 11% of males were from Holyoke and 7% of females and 7% of males were Chicopee residents.

220 detainees provided an out of county address. 193 pretrial detainees provided no address at intake.

Release

2206 (89%) of pretrial releases were from a Hampden County District Court, 182 (7%) from Hampden Superior Court. The remaining 83 were released from other courts.

886 (28%) were being held on bail of \$2000 or less. 973 detainees held without right to bail were released at court, and 93 were sentenced to time served.

Governing Offense

1128 (46%) of pretrial releases were held on violent charges. 674 were released at court, and 108 were sentenced to time served.

250 had outstanding warrants and detainers dismissed at court.

Time in Custody

Mean time in custody prior to bail was 21 days. 66% were bailed in the first 10 days and an additional 16% were bailed within 30 days.

Mean time to release at court was 44 days. 41% were released in the first 10 days and an additional 29% within 30 days.

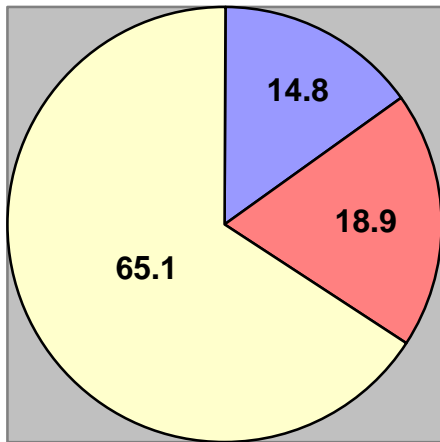
For those sentenced to "time served", the mean was 84 days. 112 (46%) served 30 days or less, 35 (15%) served 31-60 days. 31 individuals served more than 180 days prior to disposition.

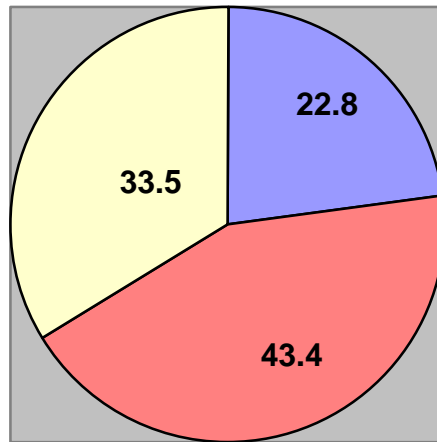

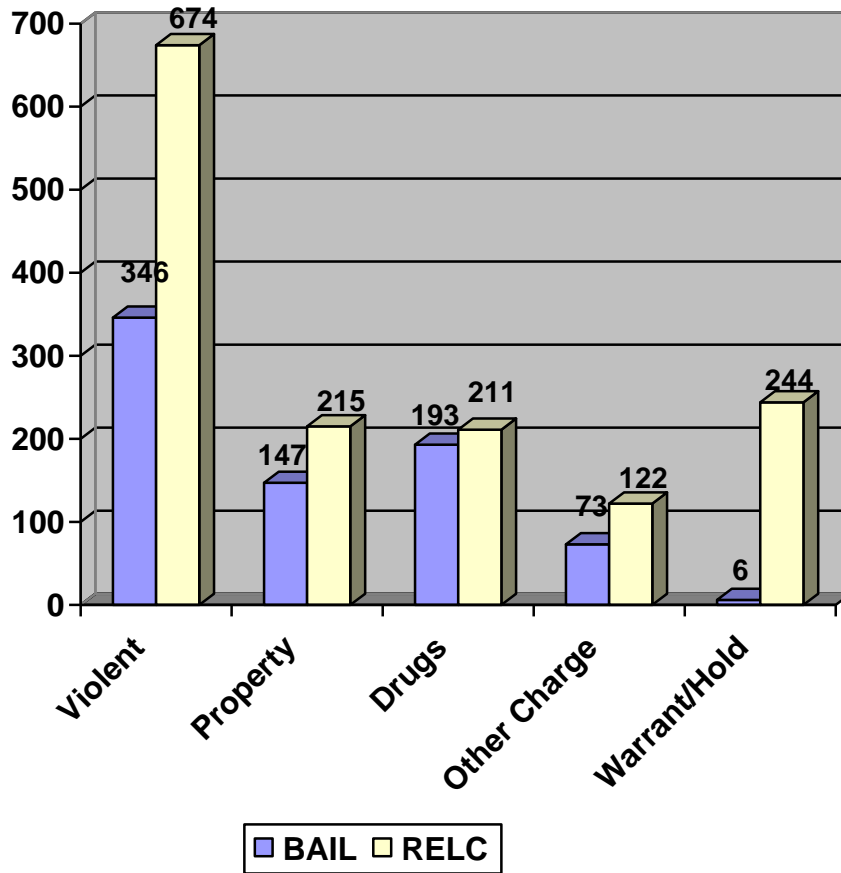

Governing Offense by Release Type



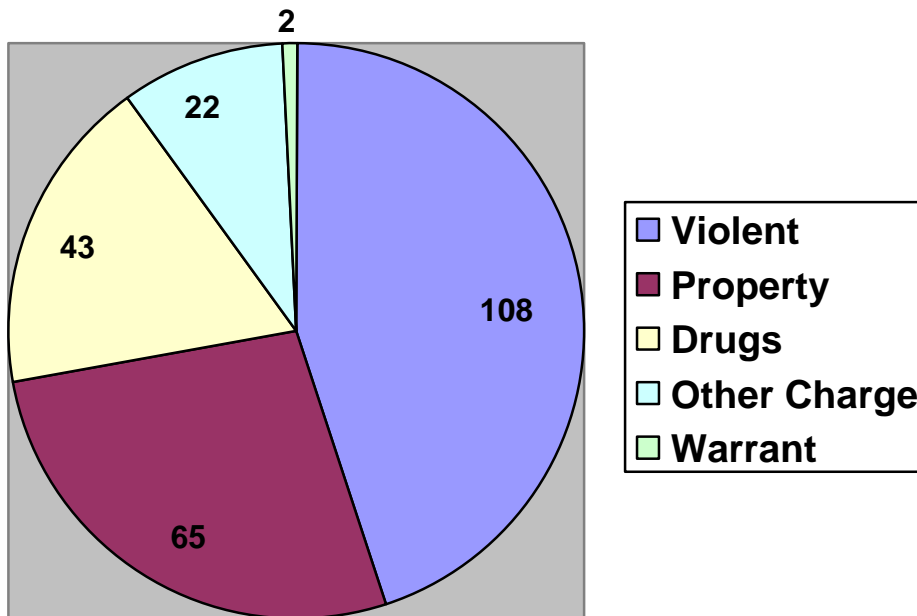

SECTION III OFFENDERS SENTENCED TO DOC

Summary

There were 227 sentences to Mass DOC in 2011, 7 females and 220 males.

These individuals were overwhelmingly minority (29% African American and 54% Hispanic).

51% of males were under age 30.

64 (28%) were sentenced for a nonviolent crime, 153 (68%) for a violent crime and 10 (3%) for a parole violation.

Mean time to disposition for a nonviolent case was 307 days, for a violent non-murder case, 305 days.

11 men were sentenced on charges of murder or manslaughter. Seven received a life sentence. Mean time to disposition was 585 days.

19 men were sentenced for a sex offense. Most common sentence was 5-7 years.

The most common sentence for a nonviolent offense was 3 years to 3 years and a day.

Most common sentence for a violent offense was 3-5 years.

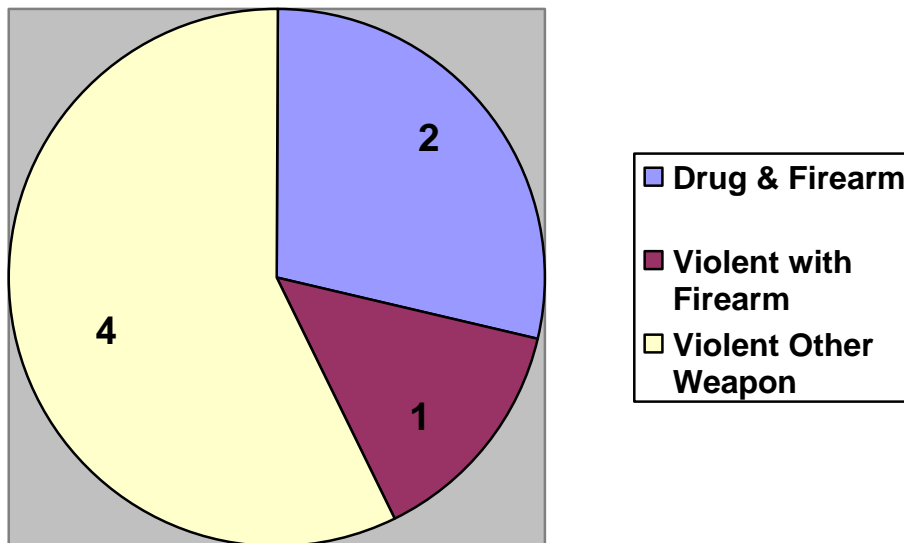
