DESCRIPTIVE OVERVIEW OF THE 2013 RELEASE COHORT

Executive Summary

At the end of each year, a descriptive overview is prepared of those offenders released during the year. This allows us to monitor any changes in the population and track trends from year to year. Data is used for population management and program development.

Sentenced offenders released to the street will be tracked for three years post release as part of our ongoing recidivism study. Recidivism rates are reported at one and three-year intervals.

There were 4945 releases from the HCSD in 2013 (894 females, 4051 males). This represents a decrease of 216 (4.2%) from 2012.

A total of 1958 sentenced offenders were released (394 females, 1564 males), a decrease of 89 (4.3%) from 2012. 1804 sentenced offenders (381 females, 1423 males) were *released to the street* via parole or expiration of sentence, a decrease of nearly 9% from the previous year. 67 sentenced offenders were released to other authorities and 6 had their sentences revised or revoked. Five DOC drug lab cases were released by the court. There were 75 releases from Foundation House and 4 HOPE parole releases (all men). One sentenced offender died in custody.

A detailed analysis of sentenced offenders released to the street can be found in **Section I**.

There were 2987 pretrial releases (500 females, 2487 males), a decrease of 2.3% from 2012. 2513 pretrial detainees were *released to the street* via bail, release at court or sentence to time served (480 females, 2033 males). 438 detainees were released to other authorities and 29 probates purged or paid their debt and were released. One pretrial detainee died in custody.

A detailed analysis of the pretrial release cohort can be found in **Section II.**

198 individuals (4 females, 194 males) received a sentence to Mass DOC and were transported to MCI Framingham or MCI Cedar Junction. 10 offenders (6 females, 4 males) were transferred to a DOC facility for a reason other than a new sentence or VOP. These reasons included commitment to Bridgewater State Hospital, DOC Reentry Program failure or court appearance on existing case.

A detailed analysis of offenders sentenced to DOC can be found in **Section III**.

SECTION I SENTENCED RELEASES TO THE STREET

Summary

Number and Gender

The breakdown by gender was 1423 males and 381 females, representing 79% and 21% of the total population, respectively.

The 1423 sentenced males released to the street in 2013 represented a 9% decrease from 2012.

The 381 sentenced females released to the street in 2013 represented a 6.4% decrease from 2012.

The release cohort represented 1715 unique individuals (1359 males, 356 females). 59 males and 23 females were released twice during 2013, 1 male and 1 female were released three times and 1 male was released 4 times.

Race and Ethnicity

The racial and ethnic breakdown is different for males and females. 78% of women identify themselves as Caucasian, 13% as Hispanic and over 8% as African American.

In contrast, 41% of men identify themselves as Caucasian, 41% as Hispanic and 18% as African American.

Age

The mean age of the female population is 34 years, 73 days; the mean of the male population is 34 years, 66 days.

12% of females are under age 25 compared to 20% of males. 26% of females and 27% of males are over age 40.

Most common age for women is 25 and 26 (tie), for men 25.

Criminogenic Factors

31% of females and 51% of males lacked a high school diploma or GED at intake.

79% of females and 74% of males were unemployed at time of incarceration.

74% of females and 86% of males admit having criminal associates.

88% of women and 93% of men were identified as having a substance abuse problem.

Residence

83% of males and 40% of females provided a Hampden County address at intake. Worcester County residents now represent 33% of the population at WCC.

55% of Hampden County offenders gave a residential address in Springfield, 14% Holyoke and 10% Chicopee.

Neighborhoods accounting for the largest number of offenders from Springfield were Forest Park (01108) and Mason Square (01109) with 24% and 22% respectively, and Central (01105) 16%.

45 offenders (14 females, 31 males) failed to provide an address at intake.

Governing Offense

17.5% of women and 33% of men were serving sentences for violent offense(s). 68 offenders were serving a sentence for a technical violation of parole and 7 for violating lifetime parole. 69% of technical violators were nonviolent offenders.

The breakdown of Lifetime Parole violation sentences in 2013 was 3 for a first offense (30 days), 1 for a second offense (180 days) and 3 for a third or subsequent offense (365 days). All violations of Lifetime Parole result in a county sentence in the offender's county of residence, regardless of the facility from which they were paroled.

Sentence

Mean sentence for women was 208 days (6 months, 28 days), for men 291 days (9 months, 21 days). Most common sentence for both genders was 180 days.

Females served a mean of 130 days (62.5% of sentence). Men served 199 days (68% of sentence).

102 women (27%) were sentenced to 60 days or less. 73 (19%) were sentenced to a year of more. For men, 264 (19%) had sentences of 60 days or less, and 463 (32.5%) were sentenced to a year or more.

Mandatory days sentenced totaled 53,595, a decrease of 26,710 days from 2012. This can be attributed to a significant decrease in OUI and school zone offenses. The CORI Reform Act grants parole eligibility at half time for several mandatory drug offenses. 17 mandatory drug offenders were paroled in 2013, saving 4,218 bed days.

Classification

The female release cohort included 374 county inmates, 6 DOC,1 Bureau of Prisons and 1 Probate. 42% of county releases were from Worcester County, 44% from Hampden County.

The male release cohort consisted of 1330 county inmates, 73 DOC, 20 Bureau of Prisons and 28 Probates.

46% of women and over 65% of men were released from lower security. 297 men attained minimum status in the Community Reentry Unit.


Release Type


Paroles accounted for 15.7% of releases in 2013, up slightly from 2012.

Parolees served approximately 54% of their original sentence compared to 73% for those who completed their sentence.






Racial Breakdown-Males %







Risks/Needs by Gender





SECTION II PRETRIAL RELEASES TO THE STREET

Summary

Number and Gender

There were 2513 pretrial releases to the street in 2013, 480 females and 2033 males.

The group represented 2244 unique individuals (404 females, 1840 males). 159 males and 48 females were released twice during the year, 17 males and 11 females were released three times and 2 females were released four times.

821 (32.7%) were bailed, 1516 (60.3%) were released at court and 176 (7.0%) were found guilty and sentenced to time served.

Race and Ethnicity

The racial and ethnic breakdown for the pretrial population reveals a higher percentage of minorities than the sentenced population, particularly among females. 33% of pretrial women are minorities compared to 22% of sentenced women. For men, the figures are 66% and 59% respectively.

11% of females and 23% of males identify themselves as African American, 22% of females and 42% of males as Hispanic, and 67% of females and 34% of males as Caucasian.

<u>Age</u>

Mean age for pretrial women was 32 years, 208 days and for men 31 years, 296 days. Most common age for men was 24, for women 27.

25% of females are under age 25 compared to 31% of males.

Overall, the pretrial population is younger than the sentenced population.

Residence

30% of females and 49% of males gave a Springfield address at booking. 7% of females and 11% of males were from Holyoke and 8% of females and 7% of males were Chicopee residents.

285 detainees provided an out of county address. 237 pretrial detainees provided no address at intake.

Release

1222 (49%) of pretrial releases were from Springfield District Court, 970 (39%) from the other Hampden County District Courts and 186 (7%) from Hampden Superior Court. The remaining 135 (5%) were released from other courts.

924 (37%) were being held on bail of \$2000 or less, 65 of whom were ultimately sentenced to time served. 974 detainees held without right to bail were released at court, and 75 were sentenced to time served.

Governing Offense

1055 (42%) of pretrial releases were held on violent charges. 645 were released at court, and 65 were sentenced to time served.

254 had outstanding warrants and detainers dismissed at court.

Time in Custody

Mean time in custody prior to bail was 28 days. 60% were bailed in the first 10 days and an additional 15% were bailed within 30 days.

Mean time to release at court was 43 days. 41% were released in the first 10 days and an additional 28% within 30 days.


For those sentenced to "time served", the mean was 88 days. 78 (44%) served 30 days or less, 36 (21%) served 31-60 days. 24 individuals served more than 180 days prior to disposition.





Governing Offense by Release Type





SECTION III OFFENDERS SENTENCED TO DOC

Summary

There were 198 sentences to Mass DOC in 2013, 4 females and 194 males.

These individuals were overwhelmingly minority (29% African American and 54% Hispanic.

48% of males were under age 30.

58 (29%) were sentenced for a nonviolent crime, 112 (57%) for a violent crime and 28(14%) for a parole violation.

Mean time to disposition for a nonviolent case was 356 days, for a violent non-murder case, 298 days.

15 men and 1 woman were sentenced on charges of murder or manslaughter. Eight men received a life sentence. Mean time to disposition was 716 days.

14 men were sentenced for a sex offense. Mean minimum sentence was 9.5 years.

The most common sentence for a nonviolent offense was 3 years to 3 years and a day.

Most common sentence for a violent offense was 2-3 years.


